**Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Canolfan Ieuenctid Tysul Youth Centre, Llandysul, on 11 April 2011**

1 Mynychodd **Heddwlas Dafydd Jones** y cyfarfod, gan sôn am y byrgleriaethau a'r arrestiadau, y fandaliaeth a'r ymddygiad gwrthgymdeithasol a welwyd yn Llandysul yn ddiweddar. Cafwyd nodyn gan Mr Davies am y digwyddiadau a welwyd ar y brif stryd yn hwyr gyda'r nos/yn ystod oriau mân y bore. Yn ogystal, cafwyd llythyr wrth Mr Butler ynghylch y fandaliaeth a gyflawnwyd yn ddiweddar yn yr Eglwys, ac adroddwyd bod y rhai y credir eu bod yn gyfrifol am hyn, wedi cael ymweliad, ynghyd â'u rhieni, ond nad oes modd cymryd unrhyw gamau pellach gan nad oes recordiad CCTV o'r digwyddiad dan sylw. Cyfeiriwyd at sŵn cerbydau Rali. Mae'r heddlu wedi tynnu yn ôl o'r broses o brynu gwn mesur cyflymder ar gyfer y gymuned. Adroddwyd am bobl sy'n goryrru ym Mhren-gwyn a Phont-siân./ **Pc Dafydd Jones** attended the meeting and addressed the recent burglaries and arrests, vandalism and anti-social behaviour at Llandysul. A note of incidents was received from Mr Davies regarding late night/early morning incidents on the main street. Letter was also received from Mr Butler in connection with the recent vandalism at the Church and it was reported that those believed to be responsible have been approached together with their parents but no further action can be taken as there is no CCTV coverage for the particular incident. Noise of Rally vehicles was referred to. The police have withdrawn from the proposed purchase of a speed gun for the community. Speeding at Prengwyn and Pontsian was reported.

Cyng/Cllr Keith Evans – Llandysul a Phontweli Ymlaen Gollyngiad/Dispensation.
- 4 **Cofnodion/Minutes:** Derbyniwyd bod cofnodion y cyfarfod misol a gynhaliwyd ar 14 Mawrth 2011 yn gywir, yn unol â diwygiad, ac fe'u llofnodwyd gan y Cadeirydd/Minutes of monthly meeting held on 14 March 2011 were accepted as correct subject to amendment and signed by the Chair.

Adroddodd y Clerk ein bod wedi cael ein hanfonebu ddwywaith gyda SWALEC am y Goleuadau Nadolig ac y bydd ad-daliad yn cael ei wneud.

  - ii) **Gŵyl Fwyd 2011** – (a145) Cynigiodd Cyng Wyn Evans ein bod yn cytuno rhoi £2,000 mewn egwyddor, eiliwyd hyn gan Gyng Philippa Davies ac fe'i derbynwyd.
- c) **Macmillan** – (a142) Cynigiodd Cyng Keith Evans ein bod yn rhoi £250, eiliwyd hyn gan Gyng Wyn Evans ac fe'i derbynwyd.
- d) **Sgwstiad 1af Llandysul** – Cafwyd ffurflen gais wedi'i llenwi ynghylch Jamboree 2011. Penderfynwyd cefnogi'r cais mewn egwyddor, ond gofynnir am gadarnhad o ran y swm y maent yn gofyn amdano.
- e) **Canolfan Geufad Llandysul Paddlers Canoe Centre** – (s19) Cafwyd cadarnhad, ynghyd ag anfonebau ategol, bod y gwaith wedi cael ei gyflawni a derbynwyd y dylid talu'r grant o £2,000 y cytunwyd arno yn flaenorol.

The Clerk reported that we have been invoiced twice by SWALEC for Christmas Lighting and a reimbursement is due.
