It was reported that a very good service was held at Llandysul Church.

 - i) **Sgwtiaid 1af Llandysul – Noson Tân Gwyllt Llandysul** – (gofynnwyd am £250) – Cynigiodd Cyng Andrew Howell y dylem roi rhodd o £250, eiliwyd y cynnig hwn gan Gyng Tom Cowcher ac fe'i derbyniwyd.
 - ii) **Cymdeithas Hanes Llandysul a'r Fro – Gwefan** – (gofynnwyd am £300) Cynigiodd Cyng Terry Griffiths y dylem roi rhodd o £300, eiliwyd y cynnig hwn gan Gyng Mrs Carolyn Reed-Rees ac fe'i derbyniwyd, ar yr amod ein bod yn cael anfonebau ategol. Estynnwyd gwahoddiad i'r aelodau fynychu cyfarfodydd y gymdeithas, a gynhelir ar y dydd Mercher olaf o bob mis yn Neuadd Tysul.
 - iii) **Capel Seion Llandysul** – Cawsom ein hysbysu nad ydynt yn bwrw ymlaen gyda'r cais am grant gan Geredigion o ganlyniad i'r gofynion niferus.

 - i) **1st Llandysul Scouts – Llandysul Fireworks Display** (£250 requested) – Cllr Andrew Howell proposed we give a donation of £250, this was seconded by Cllr Tom Cowcher and carried.

Members were invited to attend their meetings held on the last Wednesday of every month at Neuadd Tysul Hall.
 - iii) **Capel Seion Llandysul Chapel** – We were informed that they are not proceeding with the grant application with Ceredigion owing to the numerous requirements.
 - iv) **Shelter Cymru** - Completed grant application form was received and is to be discussed at the end of the financial year.

- v) **Gofal Canser Marie Curie** – Cafwyd ffurflen ymgeisio am grant wedi'i llenwi a bydd hon yn cael ei thrafod ar ddiwedd y flwyddyn ariannol.
- vi) **Urdd Gobaith Cymru – Ceredigion** – Cafwyd cais am grant ond unwaith eto, penderfynwyd y byddem yn parhau i roi rhodd dan drefniant lleol.
- vii) **Canolfan Dŵr Llandysul Aqua Centre** – Cafwyd anfonebau ategol am y gwaith a wnaethpwyd i wella'r system wresogi a derbyniwyd y dylid ysgrifennu siec am y grant a gymeradwywyd, sef £1,911.00. Tynnir eu sylw at y ffaith bod angen glanhau uwch ben y bar yn y pwll.
- viii) Cafwyd **cydnabyddiaeth derbyn rhodd** gan Sioe Pren-gwyn, Apêl y Pabi Llandysul, Carnival Llandysul a Sioe Llandysul. Yn ogystal, cafwyd gwahoddiad i fynychu Cinio Blynnyddol Sioe Llandysul yng Ngwesty Porth ar 23 Tachwedd 2012. Bydd Cyng a Mrs Tom Cowcher yn cynrychioli'r Cyngor.

6 Canllaw y Cynghorydd Da 2012:- Cafwyd trafodaeth am adrannau amrywiol.

Penderfynwyd ystyried y posibilrwydd o gael gwefan ar gyfer y Cyngor Cymuned ac i gael dyfynbrisiau. Efallai y bydd angen i ni ystyried Cynllun Cymunedol yn y dyfodol. Atgoffwyd yr aelodau o'r angen i ddarllen Canllaw y Cynghorydd Da, y Rheolau Sefydlog a'r Cod Ymddygiad o leiaf unwaith y flwyddyn. Gofynnwyd i Gyng Mrs Eileen Curry i gysylltu gyda Mr Aeron Rees, penneth Ysgol Dyffryn Teifi, er mwyn trafod y posibilrwydd o wahodd pobl ifanc o flwyddyn 12/13 i'n cyfarfod am y 10 i 15 munud cyntaf, ond yn yr un modd â'r cyhoedd, y byddai modd iddynt aros am y cyfarfod cyfan os byddent yn dymuno gwneud hynny.

7 Ffurflen Ymgeisio am Grant:- Darllenodd Cyng Andrew Howell y geiriad drafft a gynigir. Penderfynwyd y dylai'r Cyngor Cymuned gael ad-daliad os bydd Eglwysi, Capeli a/neu Sefydliadau yn cau neu os na fyddant yn bodoli mwyach cyn pen cyfnod o hyd at 3 blynedd ar ôl cael y rhodd. Yn ogystal, gofynnir am gynllun ar gyfer y dyfodol a dylid ei gynnwys yn y ffurflen.

- v) **Marie Curie Cancer Care** – Completed grant application form was received and is to be discussed at the end of the financial year.
- vi) **Urdd Gobaith Cymru – Ceredigion** – Request for a grant was received but, it was again resolved to continue to donate locally.
- vii) **Canolfan Dŵr Llandysul Aqua Centre** – Supporting invoices were received for the improvement work on heating and cheque was passed for the approved grant of £1,911.00. The need to clean above the bar in the pool is to be brought to their attention.
- viii) **Acknowledgement of receipt of donations** were received from Prengwyn Show, Llandysul Poppy Appeal, Llandysul Carnival and Llandysul Show. An invitation was also received to attend the Annual Dinner of the Llandysul Show at the Porth Hotel on 23rd November 2012. Cllr & Mrs Tom Cowcher will represent the Council.

6 The Good Councillor's Guide 2012:- A discussion took place on various sections. It was decided to look into the possibility of a website for the Community Council and to obtain quotes. Community Plan is something that we may need to consider in the future. Members were reminded to read The Good Councillor's Guide, the Standing Orders and Code of Conduct at least once a year. Cllr Mrs Eileen Curry was requested to liaise with Mr Aeron Rees headmaster of Ysgol Dyffryn Teifi School in connection with the possibility of inviting young people from year 12/13 to our meeting for the first 10 to 15 minutes but, as with public, can remain with us for the entire meeting if they wish.

7 Grant Application Form:- Cllr Andrew Howell read proposed draft wording. It was resolved that should Churches, Chapels and/or Organisations close or cease to exist up to a 3 year period after the donation is made, the Community Council is then to be reimbursed. Future plan is also to be requested and included in the form.

Roedd Elin Jones AC hefyd wedi mynchu'r cyfarfod. Y cynigion a wnaethpwyd oedd ymestyn y cyfngiadau parcio ar y brif stryd i 1 awr ac i 2 awr ar y ffordd waelod. Mae parcio digyfngiad yn cael ei ystyried rhwng y Cilgwyn a Llysawen, wrth Stryd y Bont ac o bosibl, gerllaw Gwesty Porth, ond mae Gwesty Porth wedi darparu ei leoedd parcio ychwanegol ei hun. Maes Parcio Llandysul – Fel yr hysbyswyd yn y gorffennol gan Gyng Keith Evans, nododd Cyng S Peter Evans na fyddai modd cael parcio am ddim oherwydd y byddai Trefi eraill yn gofyn am barcio am ddim hefyd os byddai hynny yn digwydd.
