Minutes of Annual Meeting of Cyngor Cymuned Llandysul Community Council held at Canolfan Ieuenctid Tysul Youth Centre, Llandysul, on 9th May 2016

- Two calls had been received in respect of boy racers in the main car park – this was currently being monitored.

- Cllr Keith Evans thanked the Council for the honour and privilege of being Chair of the Council for the 2015-16 Municipal year and reported that he had an enjoyable period.
