Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Canolfan Ieuenctid Tysul Youth Centre, Llandysul, on 12 September 2011

1 **Ymweliad – Camerâu CCTV/Fandaliaeth** – Cafwyd neges ffôn (heddiw) wrth **Gyng Gareth Williams** yn ymddiheuro na fyddai modd iddo fynychu, ac ni chafwyd manyleb/dyfybrisiau. Mynychodd **Pc Dafydd Jones** y cyfarfod ac unwaith eto, cadarnhaodd ei fod yn cefnogi'r camerâu CCTV a gynigiwyd ar gyfer Llandysul. Yn ogystal, cafwyd adroddiad gan Pc Dafydd Jones ynghylch fandaliaeth yn Llandysul, a nodwyd bod y troseddwyd wedi cael eu dal. Penderfynwyd rhoi camerâu CCTV ar Agenda y cyfarfod nesaf a bydd y clerc yn anfon y manyleb ymlaen at Gynghorwyr ar ôl iddi ei chael/**Visit – CCTV Cameras/Vandalism** – A telephone message apologising for not being able to attend was received today from **Cllr Gareth Williams** and specification/quotes had not been received. **Pc Dafydd Jones** attended the meeting and again confirmed his support for the proposed CCTV cameras for Llandysul. Pc Dafydd Jones also gave a report on vandalism at Llandysul and the recent offenders have been caught. It was decided to place CCTV cameras on the Agenda for the next meeting and the clerk will forward the specification to Councillors on receipt.

Cymdeithas Ysgol Tregroes – Cyng/Cllr Peter Davies (ond ni adawodd yr ystafell/but did not leave the room).

4 **Cofnodion/Minutes:** Derbyniwyd bod cofnodion y cyfarfod misol a gynhaliwyd ar 11 Gorffennaf 2011 yn gywir, yn unol a diwygiad, ac fe'u llofnodwyd gan y Cadeirydd/Minutes of monthly meeting held on 11 July 2011 were accepted as correct, subject to an amendment and signed by the Chair.

5 **Materion yn Codi** – Dylai Cofnodion mis Gorffennaf dan “7 a)” Gorfodi Parcio Sifil – Cyngor Sir Ceredigion – ddarllen “Cawsom ein hysbysu o'r ffaith bod y cam o drosglwyddo pwerau o'r Heddlu i'r Cyngor o dan sylw, a nodwyd a derbyniwyd hynny” ac fe'i ddiwygiwyd. Cafwyd adroddiad byr gan Gyng Mrs Eileen Curry ynghylch yr Adolygiad o Ddosbarthiadau Etholiadol, Mannau Pleidleisio a Gorsafoedd Pleidleisio yn Etholaeth Seneddol Ceredigion – Cynigion Drafft a Chynllun Datblygu Lleol Sir Gaerfyrddin.

5 **Matters Arising** – The July Minutes under “7 a)” Civil Parking Enforcement – Ceredigion County Council – should read “We were notified that the transfer of powers from the Police to the Council is being considered and was noted and accepted” and was amended. Cllr Mrs Eileen Curry gave a brief report on the Review of Polling Districts, Polling Places and Polling Stations in the Ceredigion Parliamentary Constituency – Draft Proposals and the Carmarthenshire Local Development Plan.

6 **Rhoddion** – (Datgelwyd buddiannau fel y nodir uchod)

(i) **Cymdeithas Ysgol Tre-groes a'r Cylch** – Cafwyd anfonebau am y gwaith o ddymchwel yr hen Neuadd a rhoddwyd siec er mwyn talu'r grant o £4,500 a gymeradwywyd.

(ii) **Carnifal Llandysul** – Cafwyd anfonebau a rhoddwyd siec er mwyn talu'r grant o £500 a gymeradwywyd. Yn ogystal, cafwyd gwahoddiad i gynrychiolydd fynychu tafarn Half Moon ar 7 Medi 2011 i gael lluniaeth ysgafn. Adroddodd Cyng Andrew Howell ei fod wedi mynychu a bod sieciau wedi cael eu cyflwyno i fudiadau ac elusennau lleol.

(iii) **Sioe Pren-gwyn** – Cafwyd anfonebau a rhoddwyd siec er mwyn talu'r grant o £300 a gymeradwywyd. Cafwyd 2 docyn i'r sioe.

(iv) **Sioe Llandysul** – Cafwyd anfonebau a rhoddwyd siec er mwyn talu'r grant o £500 a gymeradwywyd. Cafwyd 2 Docyn ac er gwaethaf y tywydd, bu'r diwrnod yn un llwyddiannus.

(v) **Canolfan Deuluoedd Llandysul** – Gofynnwyd i ni am rodd o £910 er mwyn cyflwyno Rhaglen Bwyta'n Iach a Llyfr Ryseitiau. Cynigwyd gan Gyng Wyn Evans ein bod yn cytuno mewn egwyddor i roi rhodd o £910, eiliwyd hyn gan Gyng Philip Marchant ac fe'i derbyniwyd. Penderfynwyd gofyn am gadarnhad y bydd y prosiect hwn yn cael ei hysbysebu mewn ffordd ddigonol.

(vi) **Eglwys Tre-groes** – Gofynnwyd i ni am rodd o £5,000 tuag at y gwaith i drwsio'r to. Ni chafwyd y wybodaeth y gofynnwyd amdani ac a ddylai gyd-fynd gyda'r ffurflen cais am grant ac roedd y Clerc wedi eu hysbysu na fyddai modd i ni drafod eu cais nes byddai gwybodaeth ddigonol yn cael ei darparu. Penderfynwyd ystyried cefnogi'r cais mewn egwyddor gan aros am wybodaeth bellach lle byddai rhagor o ystyriaeth yn cael ei rhoi gyda'r holl wybodaeth a dderbynnir mewn golwg.

6 **Donations** – (Declaration of interest as above)

(i) **Tregroes School and District Association** – Supporting invoices were received re demolition of the old Hall and cheque issued in payment for the approved grant of £4,500.

(ii) **Llandysul Carnival** – Supporting invoices were received and cheque issued in payment for the approved grant of £500. An invitation was also received for a representative to attend Half Moon on 7 September 2011 for light refreshments. Cllr Andrew Howell reported that he had attended and cheques were issued to local organisations and charities.

(iii) **Prengwyn Show** – Supporting invoices were received and cheque issued in payment for the approved grant of £300. 2 tickets to the show were received.

(iv) **Llandysul Show** – Supporting invoices were received and cheque issued in payment for the approved grant of £500. 2 Tickets were received and despite the weather had been successful.

(v) **Llandysul Family Centre** – We were asked for a donation of £910 in connection with the introduction of a Healthy Eating Programme and Recipe Book. Cllr Wyn Evans proposed that we agree in principle to give a donation of £910, this was seconded by Cllr Philip Marchant and carried. It was decided to request confirmation that this project is sufficiently advertised.

(vi) **Eglwys Tregroes Church** – We were asked for a donation of £5,000 towards repair work to be carried out on the roof. The requested information which should accompany the grant application form was not received and the Clerk had advised them that we would not be able to discuss their application until sufficient information is received. It was decided to consider supporting in principle pending further information at which time further consideration would be given in view of all the information received.

Bydd Logo'r Cyngor Cymuned yn ymddangos ar daflenni gwybodaeth y Bws Cymunedol ac ar hyn o bryd, maent yn gwneud paratoadau er mwyn casglu pobl a'u cludo i Landysul unwaith yr wythnos.

(ix) Anfonwyd **ffurflenni cais am grant** ymlaen at Eglwys Pont-siân, Shelter Cymru, Cymorth i Ddiodefwyr a Chanolfan Therapi Ocsigen Aberteifi Cyf.

7 Cyngor Cymuned – Bancio – O ystyried y ffaith bod Banc HSBC yn Llandysul i gau'n sydyn, gwnaethpwyd penderfyniad unfrydol i agor cyfrif gyda Nat West, Llandysul. Anfonir llythyr at HSBC yn mynegi ein siom.

8 Adolygiad o'r Gyllideb hyd yn hyn – Adolygwyd y gyllideb hyd yn hyn gan y Cyngor.

9 CAVO – Adroddiad am y Cyfarfod ynghylch Trafnidiaeth – Yn absenoldeb Cyng Tom Cowcher, penderfynwyd rhoi'r mater ar yr Agenda nesaf.

10 Cynnal a Chadw yn ystod y Gaeaf/Biniau Halen – Roedd y Cadeirydd a'r Clerc wedi mynychu'r cyfarfod ym Mhenmorfa. Roedd Meini Prawf Asesu a chadarnhad o'r prisiau wedi cyrraedd erbyn hyn, ac fe'u dosbarthwyd. Rydym yn aros o hyd am ymateb U Ll C ynghylch yswiriant. Rhoddwyd awdurdod dirprwyedig i Gynghorwyr Douglas Davies, Wyn Evans ac Andrew Howell i gyfarfod a thrafod lleoliadau posibl er mwyn storio halen, a chontractwyr lleol sydd ar gael er mwyn llenwi'r biniau. Byddant yn adrodd yn ôl i'r Clerc, a fydd yn gofyn am ddyfynbrisiau er mwyn cynnal trafodaeth bellach ynghylch y mater yn ystod y cyfarfod nesaf.

(vii) **Neuadd Pontsian Hall** – We were asked for a donation of £10,000 for renovation work. It was decided to agree in principle to support but await details of the quotes before considering an amount. It was also decided to confirm our support in respect of other grant applications they are making.

(viii) **Acknowledgement of Receipt of Donations** were received from Y Garthen and Llandysul a Phontweli Ymlaen re Food Festival together with an invitation to attend the River Festival. Community Council Logo will appear on the information leaflets for the Community Bus and are currently making preparations to collect people once a week to come in to Llandysul.

(ix) **Grant application forms** have been forwarded to Eglwys Pontsian Church, Shelter Cymru, Victim Support and Oxygen Therapy Centre Cardigan Ltd.

7 Community Council – Banking – In view of the fact that HSBC Bank at Llandysul is to close suddenly, it was unanimously decided to open an account with Nat West, Llandysul. A letter to be forwarded to HSBC expressing disappointment.

8 Review of Budget to date – The budget to date was reviewed by the Council.

9 CAVO – Report on Transport Meeting - In the absence of Cllr Tom Cowcher it was decided to place the matter on the next Agenda.

10 Winter Maintenance/Salt Bins – Chair and Clerk had attended the meeting at Penmorfa. Assessment Criteria together with confirmation of prices has now been received and circulated. We continue to wait for the response from OVW regarding insurance cover. Delegated authority was given to Cllrs Douglas Davies, Wyn Evans and Andrew Howell to meet to discuss possible locations for storage of salt and local contractors that are available to fill the bins. They are to revert back to the Clerk who will then request quotes for further discussion at the next meeting.
