1 **Ymweliad/Visit** –

Roedd PCSO Shan Davies yn bresennol yn y cyfarfod, a gofynnwyd am ei chymorth i symud car sydd wedi parcio mewn ffordd anghyfreithlon ym maes parcio y Cyngor Cymuned ger y feddygfa. Roedd y clerwr wedi gofyn am arweiniad gan Un Llais Cymru, a phenderfynwyd y dylai PCSO Shan Davies ofyn mewn ffordd gwrtais i'r perchennog ei symud cyn pen 14 diwrnod. Yn ogystal, atgoffodd y Cyngor bod Llandysul yn cymryd rhan mewn cynllun gwarchod tafarndai a bod tri o bobl wedi cael eu gwahardd. Yn ogystal, nododd na chafwyd cadarnhad y byddai'r Orsaf Heddlu yn cau, a phenderfynwyd ysgrifennu at Gomisiynydd yr Heddlu unwaith eto, gan nodi pa mor bwysig yw presenoldeb parhaus yr heddlu yn Llandysul.

PCSO Shan Davies was present at the meeting where her assistance was asked with moving an illegally parked car in the Community Council's car park by the surgery. The clerk had asked for guidance from One Voice Wales and it was decided that PCSO Shan Davies politely ask the owner to move it within 14 days. She also reminded the Council that Llandysul was involved in the pub watch scheme and three people had been banned. She also stated that it had not been confirmed that the Police Station was closing and it was decided to write to the Police Commissioner again stating how important for continued police presence in Llandysul.

Awel Deg Following the meeting on the 28 July 2014 with representatives from the Community Council it was reported that they had clarified a lot of issues.

Memorial Park It was reported that the memorial park had received funds for this financial year. It was decided that the clerk seek clarification as to who's responsibility it is to maintain the disabled access to the park as at the moment it is not safe.
