#### **5 Matters for discussion**

**Christmas Lights** Cllr Abby Reid thanked Cllr Keith Evans for providing the original documents for the Christmas Lights scheme. It was decided that the clerk seeks quotes by the next meeting for the replacement of the lights as well as replacement of the timing boxes. Cllr Peter Evans also requested the clerk to discuss with Llanfihangel ar Arth and Llangeler Community Council regarding their lights and if they would want to replace them in Pontweli.

#### **Llandysul Memorial Park** (Childrens Playarea)

Quotes were received for replacing the perimeter fence of the Children's Play Area from Paul Jones & Sons Contractors and J T Jones Fencing Ltd. It was decided to accept the quotation from Paul Jones & Sons Contractors in the sum of £3672 as it included the provision of concrete posts. The clerk to contact Mr Jones to advise that the work needs to be undertaken and completed by the May half term School Holidays.

It was decided that Cllr Andrew Howell be requested to once again ask the Youth Centre to remove the plaques that are currently on the fencing.

It was decided to contact the County Council to see if it was possible to apply for a Grant to help with the costs.

The clerk reported that the draft budget for 2018-19 had been created. It will be presented for acceptance at the next meeting following receipt of March bank statement and 2017-18 end of year figure would be finalised.

### **Ward Matters**

Councillors expressed their gratitude to all groups of volunteers in Llandysul that had met once again to clean the streets.

Cllrs Keith Evans, Mike Hotson and Andrew Howell had met with Alan Hird and Aled Owen with regards to place plans and creating a questionnaire. It will be designed to allow traders and residents an opportunity to express their views and what the place means to them. A target date of the end of April has been set for the completion of the design of the questionnaire with consultation to follow in the ensuing months.

Ceredigion County Council, "Growing Mid Wales TRIP funding". Organisations and the private sector had been requested to submit their expression of interest for projects that met the schemes objectives. The Welsh Assembly would be responsible for choosing what project they would support.

Cllr Keith Evans informed the meeting that from 16 April a coach service would be going through Llandysul to Cardiff on a daily basis. The clerk to forward a copy of the timetable to all members.

Cllr Keith Evans advised that the Police and Crime Commissioner was cycling 500 miles to raise funding to combat crime and in the process would be visiting every police station in Dyfed Powys.
