Cllr Gethin Jones asked the clerk to check again with the County Council with regards to the bus stop in Pontian. Steve Williams had met with Gethin Jones and promised that the bus stop would be altered but to date nothing had happened. The clerk to write to the County Council to ask for clarification on what was happening.

It is getting increasingly difficult to find passing places between Pontian and Maesymeillion by Cwrt farm. The clerk to contact the County Council asking for more information as the land owner had agreed to provide a piece of land to the County Council to aid the improvement.

Llandysul

Over the summer a member of the public had reported sighting of rats on the High Steet in Llandysul. The clerk had reported the problem to the County Council for further investigation.

Cllr Andrew Howell reported that there was a speeding problem passing Cambrian Terrace with people exceeding the 20 mile per hour speed limit.

There have been numerous complaints regarding the weeds that are overgrowing on the public footpaths by the old Dyffryn Teifi site. It was reported that the litter bins in the carpark was filling very quickly and needed to be emptied twice a week to avoid fly tipping. The clerk to report both problems to the County Council.

A tree by Tysul Hall had wilted. The clerk to ask the County Council if they could replace it.

It was reported that more dogs were kept on leads in the park following erection of the new signage.
