**1    Ymweliad/Visit –**

**2    Datgelu Buddiannau/Declarations of Interest:** Datgelwyd budd gan Gynghorwyr Eileen Curry, Beth Davies a Peter Davies mewn perthynas â'r cais am gyllid gan Neuadd Tre-groes. **Goleuadau ar Riw Seion** – Cafwyd neges e-bost a oedd yn nodi y byddai'r goleuadau yn cael eu symud oddi yno dros y Nadolig, ond y byddent yn dychwelyd erbyn yr adeg pan fyddai ysgolion yn ailagor o ganlyniad i anghydfod gyda Thai Ceredigion ynghylch hawl tramwy cyhoeddus trwy safle Glascoed. **Trawsnewid Busnes Ceredigion** – Roedd y cleric wedi ysgrifennu i ofyn a fyddai modd i Arweinydd a Phrif Weithredwr y Cyngor fynychu ein cyfarfod ym mis Ionawr. Cafwyd neges e-bost a oedd yn nodi na fyddai'r Arweinydd ar gael ar ail nos Lun y mis trwy gydol y flwyddyn, ond y byddai modd iddynt drefnu bod Cynghorydd Dafydd Edwards a'r Dirprwy Brif Weithredwr, Eifion Evans, yn mynchy. Roedd y Cadeirydd wrth gwrrthod y cynnig hwn gan bod y Cyngor wedi nodi mewn ffordd eglur eu bod yn dymuno cael cyfarfod gyda'r Arweinydd a'r Prif Weithredwr. Penderfynwyd ysgrifennu at yr Awdurdod unwaith eto, gan ofyn i'r Arweinydd a'r Prif Weithredwr ymrwymo i fynychu cyfarfod y Cyngor Cymuned yn Llandysul, gan roi dyddiadau amgen er mwyn cynnal cyfarfod gyda'r hwyr. Byddai'r Cyngor Cymuned yn cynnull cyfarfod ar gyfer y dyddiadau a gynigiwyd.

Penderfynwyd gwneud un ychwanegiad i bwynt 11 ar ffurflen y fanyleb, sef 'ymgynggori a chael cyswllt gyda'r Cyngor Cymuned' a hefyd, newid Amlter Dewis 2 o 3 wythnos i bythefnos.

**Lights on Seion Hill**- An email had been received stating that the lights would be removed during the Christmas Period but reinstated by the time the schools would re-open due to a dispute with Tai Ceredigion regards public right of way through the grounds of Glascoed. As of 11/01/16 the lights had not returned.

**Business Transformation Ceredigion** – The clerk had written to ask if the Leader and Chief Executive of the Council could attend our January meeting. An email had been received stating that the Leader would be unavailable every second Monday of the month throughout the year but they could make available Councillor Dafydd Edwards and Deputy Chief Executive Eifion Evans to attend. The Chairman had declined this offer as the Council had clearly stated that their request was to meet with the Leader and Chief Executive. It was decided to write to the Authority requesting again that the Leader and Chief Executive commit to attending a meeting of the Community Council at Llandysul and to provide alternative dates for an evening meeting. The Community Council would convene a meeting for the dates proposed.

**Recycling Small Electrical Items** – Posters had been received to advertise the recycling of small electrical items to be held in the main Llandysul car park on 23/01/16 10.00-4.00. Posters were distributed to members to display in the Community.

Penderfynwyd y byddai Cyng Keith Evans yn archwilio'r dewis hwn ymhellach, sef cynnwys plac ar y gât, gan ofyn am brisiau gan gontactwyr arbenigol ar gyfer yr elfen hon, yn ogystal â gât newydd ar ôl trafod y mater gyda Ymddiriedolwyr y parc Coffa er mwyn cael eu safbwytiau nhw.

### **Lle Chwarae i Blant**

Esboniodd Cyng Abby Reid bod cryn dipyn o Fwsogl ar yr offer chwarae. Penderfynwyd y dylai'r cleric ysgrifennu at Abacus Cleaning a gofyn am ddyfynbris er mwyn glanhau'r mwsogl oddi ar yr offer chwarae yn y parc ac o'i gwmpas.

Gwnaeth y Cadeirydd longyfarch Siop Dewi yng Nghapel Dewi ar gael ei chynnwys mewn rhestr fer am wobr arall gan y Gynghrair Cefn Gwlad. Penderfynwyd y dylai'r cleric ysgrifennu at bwylgor Siop Dewi i'w llonyfarch am eu cyflawniadau yn y gorffennol ac i ddymuno pob lwc iddynt.

### **Praesept**

Cafwyd llythyr gan Gyngor Sir Ceredigion mewn perthynas â threfniadau praesept 2016/17. O ganlyniad i bwysau ariannol ychwanegol sylweddol ar wirfoddolwyr yn ein cymuned oherwydd y ffaith bod Cyngor Sir Ceredigion wedi tynnu cymorth ariannol a gwasanaethau yn ôl, roedd y Cyngor Cymuned yn wynebu mwy o geisiadau am gymorth gan sefydliadau a gwirfoddolwyr i gynnal y gwasanaethau hyn yn Llandysul. Yn dilyn trafodaethau hir ynghylch y ffaith na fu codiad yn y praesept er 2005, penderfynwyd codi'r praesept 20%, a fyddai'n rhoi swm pellach o £6502.00. Bydd y Cadeirydd yn paratoi hysbysiad i'w anfon ymlaen at yr holl

the play area so that Contractors would be aware of the area under consideration. Following the amendments it was decided that the clerk arranged for them to be translated and forward to all members.

**Memorial Tablet** : Cllr Keith Evans had visited a stonemason in Llanybydder, but the stone mason had declined to provide a quotation due to the complexities involved, but had suggested that consideration be given the names being incorporated into a gate and reproduced on brass, copper or stainless steel. It was decided that Cllr Keith Evans explore further this option of potential incorporating a plaque into the gate and to seek prices from specialist contractors for this element as well as a replacement gate having discussed the issue with Memorial park Trustees to ascertain their views.

### **Children's Play area**

Cllr Abby Reid explained that there was a lot of Moss on the play equipment. It was decided that the clerk write to Abacus Cleaning for a quote for cleaning the moss on and around the play equipment in the park..

### **Ward Matters**

The Chairman congratulated Siop Dewi in Capel Dewi on being shortlisted for another award from the Countryside Alliance. It was decided that the clerk writes to the committee of Siop Dewi to congratulate them on past achievements and wish them gook luck.

### **Precept**

A letter had been received from Ceredigion County Council in respect of 2016/17 precept arrangements. Due to considerable additional financial pressures being placed on volunteers in our community as a consequence of the withdrawal of financial support and services by Ceredigion County Council, the Community Council was witnessing an increased request for support from organisations and volunteers to sustain these services in Llandysul. Following lengthy discussions including the fact that there had been no increase in the precept since 2005,it was decided to raise the precept by 20% which would yield a further £6502.00. The Chairman will prepare a notice to be forwarded to all councillors and put up on the website with regards to the details. 7 Councillors voted for
