- 1 **Ymddiheuriadau/Apologies** Cafwyd ymddiheuriadau gan Gynghorwyr Aled Jones, Tom Cowcher, Llŷr Jones /Apologies for absence was received from Cllrs Aled Jones, Tom Cowcher, Llyr Jones.
- 2 **Datgelu Buddiannau/Declarations of Interest** Datgelwyd budd gan Gyng Gethin Jones mewn perthynas â chais am rodd gan Sioe Llandysul / Declarations of interest were shown by Cllr Gethin Jones with regards to a request for donation from Llandysul Show.
- 3 **Cofnodion/Minutes** Derbyniwyd bod cofnodion y cyfarfod misol a gynhaliwyd ar 8 Mai 2017 yn gywir ar ôl newid enw Keith Davies i Keith Evans yng nghofnod 1 yn y golofn Gymraeg / Minutes of monthly meeting held on 8th May 2017 was accepted as correct following changing the name of Keith Davies to Keith Evans minute 1 in the Welsh column.
- 4 **Personol/Personal** Cafwyd munud o dawelwch er cof am y cyn Gynghorydd Terry Griffiths, a fu farw yn ddiweddar. Penderfynwyd y byddai'r cyngor yn rhoi £50 tuag at Apêl y Pabi er cof amdano / A minute silence was shown to former Councillor Terry Griffiths following his recent death. It was decided that the council donate £50 towards the Poppy Appeal in remembrance.

YMWELIAD / VISIT

Roedd cynrychiolwyr o grŵp Plant y Dyffryn yn bresennol yn y cyfarfod er mwyn hysbysu'r aelodau o'u cynlluniau ar gyfer safle Ysgol Dyffryn Teifi a'u cais am grant gan y loteri. Cafwyd esboniad manwl ganddynt am eu cynlluniau dros y tymor hir. Roedd Siân Williams o Aberteifi yn bresennol yn y cyfarfod hefyd er mwyn esbonio'r hyn y maen nhw wedi'i wneud yn Aberteifi wrth ail-fuddsoddi. Mae cefnogaeth y gymuned yn hollol hanfodol er mwyn i'r fenter lwyddo.

Roedd y Cynghorwyr yn dymuno'n dda iddynt gyda'r fenter.

Representation from Plant y Dyffryn was present at the meeting informing the members of what their plans are for Dyffryn Teifi School and their forthcoming lottery grant application. They gave a detailed explanation of what their long term plans are. Sian Williams from Cardigan was also present at the meeting explaining what they had done in Cardigan in re- investing. Local support is totally vital in order for the venture to succeed.

PCSO

Roedd Melanie Davies a Hannah Evans, Swyddogion Cymorth Cymunedol yr Heddlu, yn bresennol yn y cyfarfod.

Hysbysodd y Cyngor eu bod yn gobeithio sefydlu cynllun gwyliau cyflymdra ym Mhont-siân. Esboniodd hefyd bod yr Heddlu yn trefnu digwyddiad 2 ddiwrnod a fyddai'n targedu goryrru, defnyddio ffonau symudol, yfed a gyrru ac yfed dan ddylanwad cyffuriau, a threthu cerbydau. Gofynnwyd iddi a fyddai modd ychwanegu pentref Pren-gwyn i'r digwyddiad.

Hysbyswyd y Cyngor hefyd o'r ffaith bod difrod troseddol wedi cael ei achosi yn y parc chwarae ar ystad y Ffawydd. Roedd 2 unigolyn wedi cael eu dal ond oherwydd eu hoedran, nid oedd y Cyngor Sir yn dymuno mynd â'r mater ymhellach.

Cyhoeddwyd gwarant gyffuriau yn Llandysul a bydd 2 o bobl yn cael eu dwyn gerbron y llys.

Esboniodd Cyng Abby Reid bod poteli wedi cael eu darganfod yn y Parc ar ystad y Ffawydd.

Hysbyswyd y Cyngor hefyd o'r ffaith bod mewnfudwr anghyfreithlon wedi cyrraedd Llandysul ond ei fod wedi cael ei allgludo erbyn hyn.

Melanie Davies and Hannah Evans PCSO's were present at the meeting.

She informed the Council that they were hopping to set up a speedwatch in Ponsian. She also explained that the Police were organising a 2 day event targeting speed, mobile phone usage, drunk and drug driving and vehicle taxation. She was asked if Prengwyn village could be added to the event.

They informed the Council also that criminal damage had happened to the children's playpark in the Beeches. 2 suspects had been caught but due to their age there would be no criminal prosecution.

Criminal damage to Dyffryn Teifi School – 2 suspects had been identified but again due to their age the County Council did not want to take the matter further.

Drugs warrant had been issued in Llandysul 2 people to be taken to court.

Cllr Abby Reid explained that bottles had been found in the Park in the Beeches.

They also informed the Council that an illegal immigrant had turned up in Llandysul but had since been deported.

Cllr Keith Evans asked if they had any power to find out if the cars parked in the Community Council's carpark had been taxed. They would report back at the next meeting.
