4) Ceisiadau Ariannol:-

Shelter Cymru – gofynnwyd am gyfraniad o £150 gan Shelter Cymru. Penderfynwyd rhoi'r swm y gofynnwyd amdano.

Llandysul Pont Tyweli Ymlaen – gofynnodd Llandysul Pont Tyweli Ymlaen am £500 er mwyn helpu i dalu'r costau o gyflwyno Gŵyl ar ffurf Digwyddiad Cerdded yn Llandysul. Penderfynwyd rhoi'r swm y gofynnwyd amdano ar ôl i'r digwyddiad gael ei gynnal.

5) Materion i'w trafod

Parc Coffa Esboniodd Cyng Keith Evans bod y plac coffa yn ei le erbyn hyn. Diolchodd i Gyng Wyn Evans, Cyng Tom Cowcher a Mr Wally Davies am eu cymorth gydag agweddau amrywiol ar y gwaith. Cytunodd y Cyngor y dylai Cyng Keith Evans roi amlinelliad o'r prosiect i Gymdeithas Hanes Llandysul, sef gwybodaeth am gefndir y gwaith o gomisiynu'r plac.

Penderfynwyd ymhellach y dylid ffurfio is-bwyllgor yn cynnwys Cynghorwyr Keith Evans, Beth Davies a Tom Cowcher er mwyn trefnu digwyddiad i gysegru a dadorchuddio'r plac.

Matters Arising:-

Christmas Lights– The clerk had obtained a price for new Christmas lights to fill the gap that had previously been damaged. £320 for 100m with 1m spacing between the bulbs or £490 for 100m with 50mm spacing from Festive Lighting. It was decided that following receiving permission from the owner of Bryntawel that the clerk contact Derwen Lighting to obtain a cost of re-instating the Lights and order the 50mm spaced lights.

School Closures The County Council had responded to the clerks request for representation from the County Council to inform the Community Councillors of their long term plans in respect of the sites of Dyffryn Teifi, and Llandysul Schools following their closure and requesting that Llandysul Community Council provide specific questions that needed to be answered. It was decided that the clerk write again reaffirming the request that Members / Officers of Ceredigion attend a specially convened meeting of the Community Council to explain what the long term plans for the locations are.

Rights of Way- Path no 6759

An email had been received from Nigel Nicholas explaining that as this was not a primary path they could not look at our request at present however he would keep the request on file.

Notice Board The clerk explained that the work on the notice board in Maesymeillion would be done over the summer by Mark Wilson one of the contractors.

Gŵyl Gerdd Dant A letter had been received outlining the costs involved with holding the Gŵyl Gerdd Dant in Llandysul in 2017. It was decided that the Community Council donate £1500 in this financial year and a further £1500 in the next financial year as it would bring a significant boost to the economy in the Llandysul Area.

Ras yr Iaith It was reported by Cllr Keith Evans that Ras yr Iaith had been very successful with more than 70 runners taking part and with 11 establishments financially supporting the event in the Llandysul leg.

Matters Requiring Decisions

4) Funding Applications:-

Shelter Cymru - £150 contribution was requested by Shelter Cymru. It was decided to donate the requested amount.

Llandysul Pont Tyweli Ymlaen - £500 was requested from Llandysul Pont Tyweli ymlaen to help with the costs of introducing a Walking Event Festival to Llandysul. It was decided to donate the requested amount at the conclusion of the event.

Memorial Park Cllr Keith Evans explained that the memorial plaque was now in place. He thanked Cllr Wyn Evans, Cllt Tom Cowcher and Mr Wally Davies for their assistance with various aspects of the work. The Council agreed that Cllr Keith Evans provide an account of the project to the Llandysul History Society of the relevant background

Llandysul

Roedd Cyng Keith Evans yn dymuno diolch i Bwyllgor Cau'r Llyfrgell am eu holl waith caled, ac estynnodd ei gefnogaeth llawn iddynt.

Tynnodd Cyng Keith Evans sylw'r Cyngor at y ffaith y byddai John Jones, Swyddog Tân, yn ymddeol yn dilyn 29 o flynyddoedd gyda'r gwasanaeth Tân ac Achub. Penderfynwyd ysgrifennu llythyr o ddiolch at Mr Jones er mwyn cydnabod ei wasanaeth hir a ffyddlon i'r Gymuned.

Esboniodd hefyd bod unigolion niferus yn yr ardal leol wedi cael gwobrau gan Gyngor Chwaraeon Ceredigion yn ddiweddar yn ei seremoni Wobrwyo Ryngwladol ym Mhenmorfa Aberaeron, er mwyn cydnabod eu cyflawniadau ym maes chwaraeon.

It was further resolved to form a sub-committee consisting of Cllrs Keith Evans, Beth Davies and Tom Cowcher to organise a dedication and unveiling event of the memorial plaque. It was also unanimously agreed that Cllr Terry Griffiths should perform the unveiling of the plaque.

It was also decided that as the gate into the memorial park needed refurbishment, that following obtaining permission from the Park Trustees that the Community Council authorise Cllr Keith Evans to proceed to ensure that this element was completed by the date of the unveiling ceremony. He had obtained a quotation in the sum £865 plus Vat from Euros Morris who had previously tendered the lowest quotation for work appertaining to the total renewal of the Gate.

Cllr Carolyn Reid Rees explained that the dog bins in the park was overflowing. It was decided that Cllr Aled Jones informs Cymdeithas Chwaraeon of the issue.

Children's Play area

The clerk to check again with ROSPA regarding the annual safety checks.

It was decided that the clerk contact Steve Parkin Llandysul Youth Centre to inform him that it was three bins with lids that was needed to be installed for the play area in the Memorial Park.

Ward Matters

Pontsiân/Capel Dewi – Cllr Gethin Jones explained that he had been in an event at Penrhiwllan regarding defibrillators which cost £750 from the First Response Service. It was decided that Coucillors Douglas Davies, Gethin Jones, Beth Davies and Andrew Howell undertakes research to ascertain whether there were appropriate and suitable locations for the siting of such equipment in every Ward of the Llandysul Community Council area.

It was explained that there is a road closure sign in Capel Dewi with this not being the case which could lead to businesses losing custom as a consequence. It was decided that the clerk write to the County Council asking if something could be done about the matter.

Llandysul

Cllr Keith Evans expressed his gratitude and full support to the Library Closure Committee for all their hard work.

Cllr Keith Evans brought to the attention of the Council that John Jones Fire Officer who would be retiring following 29 years with the Fire and Rescue service. It was decided that a letter of thanks be sent to Mr Jones in recognition of his long and loyal service to the Community.
