1 Ymweliad/Visit –

PCSO

Roedd PCSO Shan Davies yn bresennol yn y cyfarfod er mwyn rhoi diweddariad am y digwyddiadau yn Llandysul dros y mis diwethaf. Roeddent wedi cael 1 arrestiad gwarant cyffuriau cadarnhaol ac un digwyddiad ymddygiad gwrthgymdeithasol mewn perthynas â'r Clwb Ieuenctid. Maent yn parhau i gynnal profion cyflymdra yn Heol Llynnyfran ac mae'n bosibl y byddant yn ystyried cyflwyno rampiau atal cyflymder yn y dyfodol, ond ar y cyd ag Adran y Prifyrdd Cyngor Sir Ceredigion. Yn dilyn y cyfarfod gyda'r Comisiynydd Troseddu, nid oedd unrhyw gynlluniau i gau'r or saf heddlu yn Llandysul yn fuan, ond efallai yr ystyrir ail-leoli'r or saf.

PCSO Shan Davies attended the meeting with an update on events in Llandysul over the past month. They had 1 positive drugs warrant arrest and one anti social behaviour incident regarding the Youth Club. Speed checks are still being made in Llynnyfran Road and possibly they would be looking into introducing speed ramps but in conjunction with Ceredigion County Council's Highway's Department in the future. Following the meeting with the Crime Commisioner there were no imminent plans to shut police station in Llandysul but looking maybe to relocate the station.

Salt Bin

A letter was received from County Couillor Peter Davies following a request by a member of the public for a Salt bin to be placed in Prengwyn. The member of the public expressed that he would be responsible to spread the salt as required. It was decided that the clerk write to Highway's Property and Works asking if this would be possible. If not the the Community Council would look at the request again before next winter.

5) Matters for discussion

Insurance – A letter was received from the Council's insureres with the premium for 2015/16. It was decided that we accept the quotation for 5 years Long Term Agreement for £660.68.

Floral Display – Following receiving maps from Mr Paul Arnold as to where the flower display's were located in Llandysul a lengthy discussion was held. Cllr Roy Davies had made a diagram outlining where all the flower display's were which showed many variances from the County Council's documents. Following a lengthy discussion it was decided that the Community Council would only carry on with the flower troughs as watering all the flowers would be expensive. It was decided that the clerk ask three people to tender for the watering of these, Mark Wilson, Meredith Williams and The Greenhouse, the watering to be done once a week from Mid May until Mid September. It was also decided that Cllr Roy Davies take charge if watering needed to be done more frequently during the summer months. Mr Paul Arnod had confirmed to the clerk that he would give the Community Council a water bowser.

Cllr Roy Evans also stated that the pavements in

anfon dogfennau at Mr Paul Arnold ar hyn o

Penderfynwyd y dylai'r clerc ysgrifennu at
Ymddiriedolwyr y Parc yn gofyn iddynt barhau i
roi'r wybodaeth ddiweddaraf i ni mewn
perthynas â'r Lle Chwarae. Roedd Parc Coffa
Llandysul wedi gwneud cais am arian yn
gynharach yn ystod y flwyddyn. Roeddent wedi
gofyn am £2500 er mwyn helpu i dalu am y gost
gyffredinol o gynnal a chadw y safle, megis
torri'r porfa. Gan bod y parc yn un o'r prif
atyniadau yn Llandysul, penderfynwyd rhoi
£2500.

Comisiynydd yr Heddlu – Yn dilyn ymweliad
gan Gomisiynydd yr Heddlu, roedd wedi esbonio
bod y wasg wedi codi Llandysul fel mater ac mai
dim ond edrych ar eu cynlluniau busnes yr oedd
ef, a chynorthwyo cymunedau o drefi o faint
tebyg. Roedd yn ystyried y cam o symud i rywle
arall yng Ngheredigion. Roedd y Cyngorwyr
yn teimlo bod Llandysul yn safle canolog iawn
yn ardal Dyfed Powys ac y byddai modd iddynt
ail-leoli i Landysul efallai.

Llandysul was becoming increasingly dirty and
covered in weeds. It was explained by Cllr Peter
Evans that this was down to the County
Council's budgetary cuts and a sweeper was only
cleaning the streets and not the pavements. It
was decided that Cllr Peter Evans would ask the
Community Council if all the other pavements in
Aberaeron o'r Lampeter are being cleaned and
swept.

Memorial Park/Childrens play area – The clerk
explained that a letter of apology was being sent
to the Park Trustee's regarding the Children's
Play Area. She also explained that Marion Bryant
was in the process of sending the documents to
Mr Paul Arnold regarding the legalities of the
Car Park. It was decided that the clerk write to
the Park Trustees asking for them to keep us
informed with regards to the Play Area. It was
also decided to ask Mr Paul Arnold for an
extension with making a decision regarding the
Play Area.

A request for funding had been received earlier
in the year from the Llandysul Memorial Park.
They requested a donation of £2500 for help
with funding the general upkeep such as grass
cutting. It was decided that as the park was one
of the main attractions in Llandysul to donate
£2500.

Police Commissioner- Following a visit from the
Police Commissioner he had explained that the
press had made Llandysul an issue and that he
was only looking at their business plans and
supporting communities of similar size towns.
He was looking possibly of relocating to
somewhere else in Ceredigion. The Councillors
felt that Llandysul was very central in Dyfed
Powys and they could possibly relocate to
Llandysul.
