1 Ymweliad/Visit –

Croesawyd Hazel Lubran, Prif Weithredwr Cavo Ceredigion, i'r cyfarfod. O ganlyniad i newidiadau niferus sy'n digwydd yn y Sir ar hyn o bryd o ran materion ariannol, esboniodd eu bod yn gofyn i'r Gymuned i fynegi ei barn. Ar 24 Mawrth, cynhelir digwyddiad yn Neuadd Tysul er mwyn dathlu'r hyn sy'n digwydd yn Llandysul. Byddai holiaduron yn cael eu dosbarthu mewn sawl man yn Llandysul. Ar ôl siarad gyda'r gymuned, bydd adroddiad yn cael ei greu a byddai modd iddynt helpu efallai trwy chwilio am ffynonellau ariannol. Matters Arising:-

PCSO Sian Davies – It was decided to contact the Headteacher in May when the new school had been transferred to the County Council to invite Sian Davies PSCO to the school

Recycling in Pontsian – The clerk informed the Council that it had been agreed for a recycling skip at Pontsian memorial Hall. Cllr Gethin Jones explained that an agreement had been signed between the Council and the Hall Committee.

Gwyl Gerdd Dant – Cllr Keith Evans explained that he had attended the Public Meeting with regards to the Gwyl Gerdd Dant. He was voted to the role Chairman of the Committee

and he explained that £40,000 needed to be raised in the area to host the event at Ysgol Bro Teifi. A concert would be held this year to launch the event.

Christmas Lighting – The clerk had requested a quotation from Derwen Lighting for replacing the missing section of Christmas Lights.

4) Funding Applications:-

☎✳️Ⓛ **Citizen Advice Bureau** - £500 contribution was requested by Ceredigion Citizen Advice Bureau. It was decided to donate the requested amount and a cheque was passed for payment.

☎✳️Ⓛ **Gwyl Wedig** - £3200 was requested

from Llandysul Pontweli Ymlaen to help with the running costs of the Gwyl Wledig Festival. A breakdown of costs were received. It was decided as they were now in receipt of a grant from the lottery to donate £1500.

☎✳️Ⓛ **History Society** - £400 was requested

for development of the history society. It was decided to donate the requested amount and a cheque passed for payment.

memorial park trustees for an annual contribution of £2500 for maintenance of the park. In the request they also asked the Community Council for a commitment to cover the same amount for the next 3 years.

5) Matters for discussion

Memorial Park The Chairman explained that a decision was needed regarding the options that had been explored for the commemorative plaque. The options under consideration was to incorporate the Plaque into a stone wall or the commissioning of a new gate incorporating a plaque. He had obtained quotations for the gated option and an indicative cost for building the plaque into the wall. Following a discussion it was decided 6 against 3 to continue with the option of the memorial wall. He explained that he would obtain quotations for the memorial wall by the next meeting.

Children's Play area

Cllr Abby Reid reported that she had inspected the play area. Middle bolts in one of the apparatuses was missing, she would replace these.

Maintenance Tenders Maintenance Tenders were received from Cymdeithas Chwaraeon, John's Groundwork and M W Services for grass cutting etc at the Children's Play Area. In the Memorial Park.
