Cllr Beth Davies thanked Cllr Keith Evans and all the other volunteers for all their hard work in trying to fix the Christmas Lights in Llandysul. Cllr Keith Evans explained that they had been very problematic this year but will be checking them in the near future to see what the problem is.

It was decided that the clerk ask for grit bins to be located at the entrance of The Beeches and Parc yr Ynn. The clerk to contact the Council to ask if they could replenish the salt in the Councils grit bins.

Three static caravans had now appeared in Maesymeillion. Clerk to contact the council again as there have been no planning application notices.

A request for funding was received from Llandysul Pontyweli Ymlaen for help with the running costs of the Annual Gardening Festival to be held on the 13-16 February 2025. It was decided to donate the requested amount of £1000.

#### **Capel Dewi**

Cllr Douglas Davies explained that the Capel Dewi road sign had still not been replaced.

#### **Llandysul**

Cllr Keith Evans explained that there are a lot of complaints that there is no parking available on the High Street meaning to loss of business to all the businesses. It was decided to ask if the traffic warden could be in Llandysul more often.

Cllr Andrew Howell reported a big pothole on the High Street outside Spar shop. The clerk to report this to the County Council.

#### **Pontsian**

Cllr Sue Lloyd explained the need of a grit bin in Maesymeillion from the Tregroes Road. The clerk to contact the County Council.

Numerous houses are without a telephone or wifi since the storm. Cllr Gethin Jones was in contact with MP Ben Lake regarding this.

Cllr Eileen Curry expressed concern with the state of the road from Carmel Chapel in Prengwyn to Pontsian. The clerk to contact the Council.

Prengwyn and Pontsian villages needed a new Welsh flags. The clerk to arrange this.
