Members extended their thanks and gratitude for the report.

- Ymddygiad gwrthgymdeithasol – esboniad am yr hyn a ddigwyddodd? **Ymateb.** *Cafwyd cwynion am gontractwyr mewn tractorau yn goryrru. Hysbyswyd y cyfarfod gan y Swyddog bod contractwyr yn aml yn gorfod gweithio oriau anghymdeithasol yn ystod y cyfnod cynaeafu ac os byddai hynny'n cael ei ystyried yn briodol ar adeg benodol, byddai heddwision yn archwilio trwyddedau a'r cerbydau sy'n cael eu defnyddio. Awgrymodd yr aelodau y dylid cynnal sesiwn codi ymwybyddiaeth gydag e.e. CFfl, marchnadoedd da byw ac wrth gael cyswllt gyda'r Undebau Amaeth.*

A warm welcome was given to PCSO Charlotte who was present at the meeting to answer any of the Councillors Questions.

The following questions were asked:-

- Are the PCSO surgeries still taking place? **Response.** *The Officer responded that visits were dependant on the availability of transport and operational priorities.*
- Anti-social behaviour – an explanation to what had happened? **Response.** *Complaints had been received regarding alleged speeding by contractors using tractor and implements. The Officer informed the meeting that contractors often had to work anti-social hours at harvest time and if deemed appropriate at a given time, officers would check licences and the vehicles being used. Members suggested an awareness raising session with e.g. Yfc, livestock markets and liaising with the Farming Unions.*

Election of Chair:- Cllr Matt Adams thanked the Council for the privilege of being Chair and reported that he had an enjoyable year and thanked all for their friendship and hard work. Councillors thanked the retiring chair for chairing the meetings so well and his hard work was appreciated by all. The retiring chair then called upon the Council to elect a chair for the 2023-24 Municipal year. Cllr Peter Evans proposed the current Vice-Chair, Cllr Andrew Howell as chair, but he declined the offer but was happy to carry on as Vice-Chair if members wished. Cllr Gethin Jones proposed Cllr Beth Davies this was seconded by Peter Evans and unanimously agreed by Members. As the newly elected chair Cllr Beth Davies thanked the retiring chair and took the chair for the remainder of chairing the meeting. (Cllr Matt Adams left the meeting at this point)

2. Declaration of Acceptance of Office to Include Code of Conduct will be signed by all Chair in advance of the next meeting.

3. Election of Vice Chair Cllr Beth Davies called upon the council to elect a Vice-Chair. Cllr Peter Evans proposed Cllr Andrew Howell remain, this was seconded by Cllr Douglas Davies and unanimously agreed by Members.

4. Election of Planning Consultees Committee All Councillors are provided with electronic copies of all applications enabling them to submit comments. In the absence of comments Clerk is able to discuss applications with the Councillors for the various wards. It was unanimously resolved to elect the following Planning Committee:- Capel Dewi Ward – Cllr Elen Grantham Llandysul Town Ward – Cllrs Andrew Howell and Mike Hotson. Tregoes Ward - Cllr Eileen Curry. Pontsian Ward – Cllr Gethin Jones. Continued delegated authority was given to the Clerk to deal with the applications between meetings by contacting the relevant members.

5. Election of Finance Committee It was resolved to elect the following to the Finance committee: - Cllrs Beth Davies, Keith Evans, Sue Lloyd and Mike Hotson.

Cllrs Keith Evans and Andrew Howell and Douglas Davies would remain as Cheque signatories.

6. Internal Auditor It was resolved to ask Mr R J Foulkes to continue as Internal Auditor.

7. Internal Control/Internal Checker:- It was resolved that Cllr Gethin Jones undertakes the tasks of Internal Control/Internal Checker.

8. Risk Assessment Appropriate steps to manage Internal Control/Risk Assessment and review of Insurance have been taken.

12 Matters Arising:-

Vacant Seats – Members were reminded that there had been no requests to become a member for the two vacant seats in the Llandysul town ward. Members were requested to identify appropriate potential members by the next meeting and to request them to submit an expression of interest letter in the role, providing some background information and experience for Council's consideration.

Due to the resignation of Matt Adams, a further vacancy now exists for the Llandysul Town Ward. The Clerk was requested to follow the set procedures for filling this vacancy and to advise the County Council accordingly. It was decided that the Councillors by next meeting try and find people to undertake a job of a Community Councillor and to bring the proposed names to the next meeting.

It was decided that the clerk inform the Council of another vacant seat in Llandysul Town Ward.
