Pontsian

Cllr Gethin Jones had asked the volunteers that undertake planting work at locations in Pontsian, to retain invoices so that they can be reimbursed by the Community Council.

It was decided that the clerk contact officers at Ceredigion's Click department noting that she could not see the maps on their system to accurately identify and plot in the locations of problems that require action by the County Council.

The clerk advised Councillors that the fixing of Capel Dewi Noticeboard had been arranged.

Hybrid Meetings

The clerk had obtained a quotation from Telemat and Cliand computers Ltd for equipment similar to what we are trialling now at Ysgol Bro Teifi. Telemat was £4858.65 and Cliand £4490.75 both included VAT. Telemat had also included a newline system for £6800.79.
