Roedd Cynghorydd Elen Grantham wedi gwneud ymholiadau gyda Cavo ynghylch diweddarau rhywfaint o'r offer chwarae. Byddai angen nodi a mesur yr offer gofynnol a chynnal gwaith ymchwil ac ymgynghori gyda phlant cyn y byddem yn gymwys i wneud cais am grant.

Dylai'r unigolyn sy'n gyfrifol am archwilio offer y parc fod wedi sicrhau cymhwyster ROSPA. Cost hyfforddiant achrededig o'r fath fyddai £320 + Taw am yr archwiliad wythnosol a £585 + Taw am yr archwiliad misol.

**4) Funding Applications:**

Wiberod Rugby

During consideration of this matter Cllr Keith Evans withdrew from the meeting room and took no part in the decision-making process. A request for donation of £300 was asked to take the Wiberod girls rugby team on tour to North Wales. It was decided to donate the requested amount.

Tysul Youth

£2000 was requested for help with taking 25 youngsters and 5 leaders to Plogonnec in Brittany. It was decided to donate £1500.

Jeï Art

Jeï Art had sent in a request for a donation of £304 to hold an event for social wellbeing for 100 attendees. As the event was held at Rhydlewis Hall it was decided not to support the event, but that consideration would be given to supporting a similar event if held in the Llandysul Community Council area.

Llandysul Show

(Cllr Beth Davies having declared her interest left the meeting and Cllr Andrew Howell Vice-Chair took the chair for consideration of the item.

£1000 was requested for support with hiring a marquee to promote local produce and crafts. It was decided to support the requested amount.

5) Matters for Discussion

**Llandysul Children's Play area**

Cllr Elen Grantham had made enquiries with Cavo with regards to updating some play equipment. There would be a need to identify and measure the equipment required and market research and consultation undertaken with children before we would be eligible to apply for a grant.

The responsible person with regards to inspecting the park equipment should be ROSPA qualified. The cost of such accredited training would be £320 +Vat for the weekly inspection and £585 + Vat for monthly inspection.

It was decided to ask the contractor that

Penderfynwyd gofyn i Rhodri Thomas, Mark Wilson a Meredith Williams a fyddent yn dymuno cynnig pris am ddarparu plinth concriid a gosod y meinciau yn eu lle yn lle chwarae Plant Llandysul.

### **Sedd Wag**

Cafwyd hysbysiad am y sedd wag yn Nhref Llandysul ac fe'i drosglwyddwyd i'r Cyngorwyr. Y dyddiad cau yw cyn 07/07/23 Roedd un aelod o'r cyhoedd wedi mynegi diddordeb mewn llenwi un o'r 2 sedd arall sydd ar gael yn ward y dref. ### **Benches**

Cllr Keith Evans explained that 6 benches had been received from the grant available to the towns in Ceredigion. It was decided to locate 2 in the Llandysul children's play area and to liaise with Barcud housing association who are responsible for The Beeches play area if they would like 2 benches to be located there with Barcud being responsible for securing them in place.

It was decided to ask Rhodri Thomas, Mark Wilson and Meredith Williams to see if they would like to provide a quotation for providing a concrete plinth and bolting the benches in place at the Llandysul Children's play area.

### **Vacant Seat**

Notice had been received for the vacancy in the Llandysul Town Ward and passed to Councillors. The closing date is before 07/07/23

One member of the public had shown an interest in filling one of the other 2 seats available in the town ward. The Clerk was asked to make contact and to request that a formal letter be submitted providing additional information and experience.

Councillor Keith Evans had prepared a Draft weeding and Planting schedule. It was decided to adopt the schedules and that tenders would be invited and based on the full term of Council.

#### Maesymeillion

Numerous people had complained to Cllr Sue Lloyd with regards of a house being built in Maesymeillion, Maes Mali. The clerk to contact the Planning department for clarification.

Caravans have been in Pantmoch Bach for months, do they need to have planning for these caravans? The clerk to contact the County Council.

#### Pontsian

Cllr Gethin Jones informed Councillors that there are traffic calming speed humps on the road from Pontsian to Alltyrodyn but with the paint markings worn away. The clerk to contact the County Council to ask if they could repaint them with the white paint as they are no longer visible to road users. Dog Fouling is on the increase in Pontsian also and they too could do with some advisory signage to remind owners of their responsibility.

Mr and Mrs Blayney had been planting flowers in Pontsian. Cllr Gethin Jones to ask them to send the receipts to the clerk.

#### Llandysul

Cllr Andrew Howell informed the Councillors that a successful party night at the Porth organised by James Jones Son and Francis (Solicitors) to raise money for the Food Bank at Llandysul.
