Calon Tysul – Application for continued financial support with running costs for Calon Tysul. The request was in the sum of £6000 p.a. Cllrs Sioned Thomas, Matt Adams, Keith Evans declared their interest in the application. Cllrs Thomas and Adams left the meeting during consideration of the application. Cllr Evans remained in the meeting as he had been given dispensation to speak and vote by the Ethics and Standards committee. Following consideration of the request, the Council resolved to provide funding for this Council term (5 years) in the sum of £6000 p.a.
