a chynnig cwestiynau ychwanegol i'r Clerc i'w hanfon ymlaen i Geredigion er mwyn cael eu hymateb. Byddai'n rhaid i'r gwaith o drefnu les ar gyfer y toiledau fynd trwy'r Adran Ystadau.

Caiff yr eitem hon a rheolaeth posibl y toiledau yn Llandysul eu cynnwys ar agenda cyfarfod mis Medi 2024.

Nododd swyddogion Ceredigion y byddent yn rhoi adroddiad am y drafodaeth a gafwyd ynghylch trosglwyddiad posibl rheolaeth y toiledau, gan ymateb i gwestiynau pellach gan y Cyngor Cymuned.

Paul Williams Buildings Facility Manager, Shaun Bettell, Senior Cleaning Officer and Linda James, Service support officer from Ceredigion County Council joined the Zoom meeting to discuss the future of the provision of toilets adjacent to the car park in Llandysul and to see whether if a sponsor or anyone would take over the funding and day to day running of the provision.. They provided Councillors with the following indicative costings.

Cost of cleaner 1hour a day 7days a week at 2024/25 estimated costs would be circa £4200  
He went on to provide illustrative costings for the previous two financial years, see below:

**N.B. Above costs do not represent total service provision costs, such as legal, insurance etc.**

Councillors were invited to forward a list of questions to the Council once they had discussed the matter further. Footfall and use of the toilets aren't great and it would not warrant a door payment system there.

A list of initial questions was compiled and members were encouraged to give the matter further consideration and provide additional questions for Clerk to forward to Ceredigion for their response. The setting up of a lease for the toilets would have to go through the Estate Department.

This item and the potential management of the toilets at Llandysul to be put on the agenda for September 2024.

Ceredigion officers advised that they would provide an account of the discussion that took place on the potential transfer of management of the toilets and responding to further questions from the Community Council.
